A full credit for any scheduled services will be issued in the event that Frogs to Dogs, LLC receives 24 hour notification from the client. In the event that Frogs to Dogs, LLC is not notified within 24 hours, the client is responsible for the full balance of the scheduled service.
2. Payment is due at the time of the first scheduled service. Payment is accepted in the form of cash or check only. Checks can be made payable to: Frogs to Dogs.
3. Frogs to Dogs representative is authorized to perform care and services as outlined in the service agreement profile. Frogs to Dogs representative is authorized by signature below to seek emergency veterinary care with release from liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable, Frogs to Dogs representative is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Frogs to Dogs and/or representative for expenses incurred.
4. In the event of inclement weather or natural disaster, Frogs to Dogs representative is entrusted to use best judgment in caring for pet(s). Frogs to Dogs representative or Frogs To Dogs, LLC will not be held liable for consequences related to such decisions. In the event of an emergency, Frogs to Dogs, LLC or representative will contact owner immediately to discuss any concerns.
5. Frogs to Dogs, LLC and representative agrees to provide the services as stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as express condition thereof, the client expressly waives and relinquishes any and all claims against said Frogs to Dogs, LLC or representative except those arising from negligence or willful misconduct on the part of Frogs to Dogs, LLC or representative.
6. Pets are to be currently vaccinated. Should a Frogs to Dogs representative be bitten or otherwise exposed to any disease or ailment received from clients animal which has

Client and Emergency Contact will be contacted if there is a problem and alternatives will be discussed at that time.
8. Signature on this contract authorizes Frogs to Dogs, LLC and representatives to take telephone reservations for future service.
9. Key(s) pick-up is required at time of contract signing for pet sitting, dog walking and/or waste removal services. In the event that the key given to the Frogs to Dogs representative by client does not allow access, any and all charges to gain entry are the pet owners responsibility. This contract authorizes the hiring of a locksmith should it be necessary. Frogs to Dogs, LLC will safely store clients key(s) for future use. Clients key(s) are custom coded as a security precaution and locked in a safe. Client is responsible for picking up any key(s), if requested.

PLEASE NOTE: The utmost care will be given in watching both your pet(s) and your home. However, due to the unpredictability of animals, we cannot be responsible for any mishaps of any extra-ordinary nature. (i.e. biting, furniture damage, accidental death, etc.) or complications in administering medications to the animal. Nor can we be liable for injury, death, disappearance, or fines of pet(s) with access to outdoors.
